Rules & Regulations:

1. These booths are for manufacturers, businesses, retailers, and individuals who market a product and/or service AND sell handmade items. An opportunity for public exposure and awareness is made possible through these rented spaces.
2. The vendor agrees to provide manpower to operate the booth according for the following schedule:
Wednesday, August 9th 4pm-10pm
Thursday, August 10th, 4pm-10pm
Friday, August 11th, 4pm-10pm
Saturday, August 12, 10am-10pm
3. Booths will remain open until the building closes during the fair. Failure to comply may jeopardize future contracts with your business or organization.
4. One space per company, all spaces are first come, first serve.
5. A picture of the booth should be included with registration.
6. Registrations received after **June 1, 2023**, will be charged a **\$25 late fee**.
7. Payment can be made with cash, check, or money order. No credit/debit payments can be accepted.
8. Refund requests may be made in writing before July 1, 2023. No refunds will be granted after August 1, 2023.
9. Each booth will be provided **one** vehicle pass allowing one vehicle to park at the fairgrounds in the designated parking lot. No vendors will be able to park inside the fairgrounds.
10. One table and two chairs will be provided.
11. The Franklin Southampton County Fair will exercise all reasonable diligence in protecting the property of exhibitors, but will not be responsible for property lost due to theft, fire, robbery, accident, or any other destructive cause, or for any injury that may arise to the public in the leased area or to Exhibitors and/or their employees while on the Fairgrounds.
12. Due to the ongoing Covid-19 pandemic, indoor vendor spaces may be moved outside to abide by state and local guidelines. If the board of directors determines that the event must be canceled due to the Covid 19 pandemic refunds will be issued.
